Opening Remarks:

Chairman Poole welcomed everyone for attending today's board meeting. He announced that he was informed by the Governor's Office that the vacancies on the Commission would be filled in the beginning of 2021. Everyone was pleased to hear this announcement.

Approval of Agenda

Chairman Poole presented the agenda. Dr. Malika Reed Wilkins made a motion to adopt the agenda. Vice Chairman Spencer R. Moore seconded the motion. There was no further discussion. The motion passed unanimously.

Approval of September 22, 2020, Meeting Minutes

Chairman Poole presented the September 22, 2020 meeting minutes. Vice Chairman Moore made a motion to approve the minutes. Dr. Wilkins seconded the motion. There was no further discussion. The motion passed unanimously.

Public Comment

Chairman Poole offered a time for Public Comment. There was no response.

Staff Report

Mr. Josh Turner presented the staff report including the Provider Scholarship Redemption Report, FY 2020 Customer Service Report, for October through December Scholarship Report. A copy of the Staff Report is attached as a part of these minutes.

Mr. Turner provided an update to the board regarding the research and evaluation project. The project is running behind scheduled due to a delay with the execution of the data sharing agreement. This has delayed the project no more than five weeks. The project is expected to be available before the conclusion of the General Assembly Legislation sessions. Mr. Turner said that he hopes a decline in COVID-19 cases will allow for an in-person presentation for the final report, perhaps in the form of a Lunch and Learn session where driver's education stakeholders and legislators can be invited to participate.

Finally, Mr. Turner reminded Commission members that the affidavit confirming that public officers took no official action in the previous calendar year that had a material effect on such public officer's private financial or business interests is due to the Georgia Government Transparency and Campaign Finance Commission by January 31, 2021. The instructions and information were emailed to Commission members on December 18, 2020. If Commission members have any questions, they should consult with General Counsel, Ms. Amy Radley or Mr. Turner.

Chairman Poole asked the board members, if they had any questions for Mr. Turner or Ms. Shenee Bryan regarding the timeline of the project. There was no further discussion.

Chairman Poole acknowledged Ms. Shenee Bryan and her team for doing an outstanding job. He asked were there any additional comments she would like to add at this time. Ms. Bryan thanked Chairman Poole for the opportunity to provide an update regarding the evaluation project. Ms. Bryan stated it has been a great pleasure working with the Georgia Department of Driver's Services team. Everyone displayed dedication by working late hours to retrieve the data extractions. The data match rate has been successful by identifying 94% of the GDEC applicants by the DDS database and 89% of all young adults who has been involved in any fatal crashes in DDS database. This is great news regarding the findings thus far.

Amendment to Fiscal Year 2021 Budget

Chairman Poole recognized Mr. Turner to present the proposed budget amendments. Mr. Turner requested that the scholarship funds be reduced by \$17,000.00 and staff travel be reduced by \$10,000.00 and that computer charges be increased to \$3,000.00 for the purchase of two new computers, that Research and Evaluation be increased by \$5,000.00 for data extraction costs, and Software Support be increased by \$19,000.00 to enhance the Commission's online portal to include electronic submission of provider contracts. Dr. Wilkins made a motion to approve the budget amendments. Vice Chairman Moore seconded the motion. There was no further discussion. The motion passed unanimously.

Other Business

Chairman Poole opened the floor for other business. There was no further discussion.

Vice Chairman Moore made a motion to adjourn. Dr. Wilkins seconded the motion. The motion to adjourn passed unanimously.
